# Atheism in American Culture

An Undergraduate Course

### **Course Description**

This course is appropriate for any undergraduate interested in the role of atheists, freethinkers, doubters, and the nonreligious in America. Blending approaches from history, sociology, cultural studies, and media studies, this course will be of particular interest to students in Religious Studies, American Studies, Sociology, and American History. Although a minority group in the United States (and one perceived as suspect), atheists and nonbelievers have played central roles in the nation's history in many pivotal moments. This course will provide students with knowledge of these historical roles, as well as with a foundation for understanding the social and cultural position of atheists throughout history and in the contemporary moment. This will include discussions of central figures, movements, and organizations, and also of atheism "on the ground." The materials used for this course therefore range from secondary historical and sociological sources to personal narratives and contemporary media products.

### **Course Objectives**

The goal of this course is to impart an understanding of the place of freethinking in American culture from roughly the time of the nation's founding to the contemporary era. Students will gain a working knowledge of different "varieties" of unbelief as well as their emergence or appearance in cultural moments. Together, we will explore questions including: What is the relationship between religion and nonreligion in America? What is special about the social/cultural position of atheists in America? What accounts for this position and how does it change over time? How do atheists organize, and why? How have atheists and atheist groups addressed questions of gender and race in America? What is "New Atheism" and is it "new"? Through a final project and accompanying presentation, students will gain experience with research and writing at the college level as they explore some dimension of nonreligion in America in greater depth.

### **Course Standards, Policies, & Requirements**

### Attendance and Preparedness

Attendance is required. Students are requested to notify me as soon as possible should they foresee needing to miss a class for extenuating circumstances. Absences are dealt with according to the situation, but unexcused or explained absences will directly affect the participation grade (5% for every missed class). Lateness is frowned upon; expect to experience a stink-eye the likes of which will make your skin crawl. Excessive and/or repeated lateness will result in uncomfortable conversations and will start to affect your grade like absences. Finally, students are expected to have completed assigned readings for every class, and should come to class with relevant questions or comments in mind so as to be able to engage and should we have in discussion time. The final will be 10-12 pages, due by [date]. Students are welcome (and encouraged) to meet with me to explore and discuss topics.

All students will prepare a 10-minute presentation of their final project to share on the final day of class. Multimedia presentations are encouraged.

Due dates and times are firm; papers will only be accepted late if students have discussed circumstances prior with me.
